1 . Definitions

- ② "Product" refers to a plasmid vector or a adeno associated virus vector (AAV) containing a photoactivated adenylyl cyclase (mOaPAC) structural gene provided by HAMAMATSU PHOTONICS K.K., listed in the column of Products used of the Consent, including, but not limited to its derivatives (plasmid vector produced or a DNA fragment obtained from AAV-infected samples, addition/deletion/change to the nucleotide sequence of the vector).

2 . Terms of Use and Miscellaneous

- ① Customer shall acknowledge that Product is a prototype and has the potential of possessing a hazardous nature, and is provided on an as-is basis, without any warranty, including but not limited to its function and performance, and the intended use thereof is limited to the research of Customer.
- ② Customer shall use Product only in the location stated in the column of Laboratory/department name of the Consent. In addition, Customer shall have employees who handle Product in Customer's laboratories and departments comply with this Conditions for Use of Research Materials and be responsible for any breach of their obligations.
